## MEMORIAL SCHOLARSHIP FUND

The *Jerry A. Wilson, Jr. Memorial Scholarship Fund* was established by Citizens Bank & Trust Company in memory of our friend and colleague, Jerry Wilson, who passed away on January 28, 2017.

Jerry began his career at Citizens Bank & Trust Company in 1950 and was promoted to President in 1965. At 34, Jerry was the youngest bank president in Virginia and served 37 years in that position. He retired from the bank in 2002 after 52 years of service.

Jerry was committed to his community, presiding over a variety of church, civic and community organizations, and was a longtime friend and advocate of agriculture in Southside Virginia. Jerry loved farming and at one time managed two farms. He continued to farm his home-place at Wellville until his passing.

Citizens Bank & Trust Company has established this scholarship fund for students pursuing a degree in business or agricultural studies as an ongoing tribute to Jerry Wilson.
