

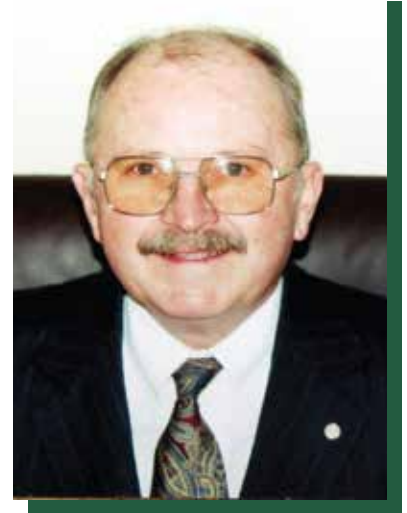
ROBERT E. JOHNSON
